

CLARK COUNTY R-1
SPECIAL MEETING - OPEN SESSION
May 20, 2020

The Clark County R-1 School Board of Education met in special session on Wednesday, May 20, 20120 at 7:00 pm. In the Library at Clark County High School located at 680 East Main Street, Kahoka, MO 63445.

Members present: Brad Sprague, President, Mark Plenge, Vice President, and Charles West, Jason Acklie, Kari Bevans, Craig Hunziker, and Kevin Ross members.

Administration present: Dr. Ritchie Kracht, Jason Harper, Jason Church, Megan Wendling, and Katrina Nixon, Principals and Ethan Allen, Assistant Principal.

Guests: Ann Dever, Jana Zinnert, Cheyene Loebach.

Mrs. Nixon presented the results of the summer school survey. According to the survey there are 120 kids, K-6 that are interested in attending with the proposed restrictions and no transportation being offered. The results favored a 4 day week (Monday - Thursday) and the hours would be 8:00 a.m. - 3:00 p.m. Middle School and Highs School will offer credit recovery, online enrichment, Algebra 1. And Pre-Algebra.

The Administration team proposed to offer summer school for 20 days, with 4 days of attendance each week and activities sent home for Friday to be completed and returned on Monday. Summer school will start June 1 and end on June 26. Classes will be kept small to maintain social distancing, breakfast and lunch will be provided in the classrooms, custodial staff will clean and sanitize the building throughout each day, and a deep clean will be done every Friday. There will be an isolation room established for anyone that may start to have Covid-19 symptoms.

Motion was made by Charles West, seconded by Jason Acklie to approve the proposed summer school plan. Aye 7. Nay 0.

Mr. Church led the discussion on summer conditioning for student/athletes starting June 3 in small groups in which Coach Plenge and head coaches will supervise so that social distancing standards are kept in place. Sanitizing equipment and other precautions will be completed between sessions. Summer conditioning will not be required but will be open to those that want to participate. The emphasis will be training our student/athletes to prevent injuries and heat

related illnesses if the fall sports season is allowed to start in August. Mr. Dooley can also offer band lessons individually and in small groups following all social distancing guidelines.

Motion was made by Charles West, seconded by Craig Hunziker to adopt the proposed fitness summer program and band summer program starting in June.

Decisions will be made on Early childhood screening and track opening for public use at the regular June board meeting. Other student activity decisions such as flag tryouts, cheerleading tryouts, sport specific activities, etc.... will be evaluated throughout the summer board meetings.
